Secure Act signed into Law!

On Friday, December 20, the SECURE Act (officially titled the Setting Every Community Up for Retirement Enhancement Act) was signed into law.

How Will This Legislation Affect Individuals and Retirement Plan Sponsors?

The SECURE Act will:

- Modify the required minimum distribution (RMD) rules for designated beneficiary accounts.
- Expand qualified tuition expenses under Section 529 of the Internal Revenue Code.
- Allow open multiple employer plans (MEPs).
- Allow long-term, part-time employees to participate in the retirement plan.
- Raise the age for RMDs from 70½ to 72.
