#### Secure Act signed into Law!

The Secure Act was passed as part of the 2020 spending bill. It focuses heavily on changes to retirement accounts and 529 Education Savings Accounts. Some of these changes are positive, but some are negative. Understanding these changes will allow you to avoid the pitfalls but perhaps also the benefits.

- > RMD start dates have been changed from the year you turn 70.5 years old to the year you turn 72 years old.
- > Provisions allowing 401K or IRA Penalty-Free Withdrawals
- > Incentives for Small Business 401K Creation.
- > Provisions for Additional 529 Usage
- > Stipends and non-tuition fellowships now count as income for IRAs
- > Part-time workers, that work at least 500 hours for 3 consecutive years can collect a 401K.
- > Also, on the negative side, are the changes to the stretch IRA.
- > Annuities as part of 401k plans. have already made it clear I am not a big fan of annuities.
